Cyber Stalking and Abuse

Whether it is stalking through social networking, harassment through text messages, or humiliation through the posting of pictures or videos, technology is changing how people can abuse, harass and stalk others at the click of a few buttons.

Someone does not need to be near you to cause fear and harm.

The use of technology to abuse, harass and stalk people is becoming increasingly common. This can include:

- Aggressive and abusive text messages or bombarded with unwanted emails
- Abusive things written online
- Passwords stop working or keep changing
- Fake profiles set up in the victim's name
- Fake emails sent to people
- Items ordered on-line in the victim's name without permission

So what can be done?

The domestic abuse risk assessment encompasses stalking (remember it's called DASH - "domestic abuse, stalking and honour-based violence"!)

If you know someone aged 16 or over who's experiencing stalking then always consider completing a DASH and referring into our local service <u>SIDAS</u>.

Somerset Integrated Domestic Abuse Service

This service has had a busy first year and has worked with over 1,100 men, women and children in Somerset.

Although this is an increase on previous years for the numbers of people accessing support, we unfortunately know, this is remains only a small proportion of the total number of people who are experiencing domestic abuse in the county. So it's important for professionals in all agencies to continue to look to spot the signs of abuse, and refer as appropriate to the Somerset Integrated Domestic Abuse Service (SIDAS).

As you may have heard, SIDAS has a "single point of access", so what does this mean?

To access SIDAS you either can telephone or email as follows:

- **Helpline 0800 69 49 999** available to all, 8am to 8pm Monday to Friday and 9am to 1pm Saturday and Sunday (These are **new** hours from 1.4.16)
- **Email general enquiries** for professionals, friends, relatives and victims heretohelp@knightstone.co.uk.
- Email secure for referrals from professionals here.tohelp@knightstone.cjsm.net.

Your call or email will be responded to by the SIDAS hub.

Remember – to send emails securely you must send from a secure email. If you don't have one, please ask your manager for advice or go to your agency MARAC representative who will have a secure email.

As a reminder, SIDAS can offer:

- Support to female **and** male victims of domestic abuse (1-2-1 and groupwork)
- 1-2-1 and groupwork support to children and young people affected by domestic abuse (male and_female).
- 1-2-1 and groupwork to perpetrators of domestic abuse (male **and** female).

Domestic Homicide Reviews – Avon and Somerset wide Review

Somerset agencies have recently been part of an Avon and Somerset wide project to collate learning from the Domestic Homicide Reviews (DHRs) that have been completed across Avon and Somerset in order to improve the safety of individuals affected by domestic abuse.

This found the following 5 main recurring lessons from the DHR's across the Avon and Somerset area:

- (1) **Communication** ensuring more of the general public including diverse groups and friends, family or neighbours know about domestic abuse and how to access services
- (2) **Domestic Abuse Policies** Not all agencies have fit-for-purpose policies
- (3) **Training** Ensuring victims with multiple needs or who are male is included in awareness training
- (4) Information Sharing Not all agencies completing DASH risk assessments, and assessments not always reflecting victims other needs (e.g. mental health, substance misuse, homelessness). Plus lack of knowledge regarding data protection or when information can be shared.
- (5) Multi Agency Risk Assessment Conference (MARAC) Inconsistencies in type of

referrals and attendance of agencies, plus action plans not always monitored at subsequent meetings.

A series of recommendations have been produced, and it is intended that a development group consisting of volunteers from across Avon and Somerset is established. National Updates

The Government recently published its new strategy to end violence against violence and women 2016-2020. You can find this online at https://www.gov.uk/government/publications/strategy-to-end-violence-against-women-and-girls-2016-to-2020

As part of their strategy the Government announced that in 2017, they will also launch a dedicated Service Transformation Fund, to encourage new approaches, and establish and embed the best ways to help victims, and their families, and prevent perpetrators from reoffending. New Government Campaign for Teenagers

The Government have recently launched a new 'Disrespect NoBody' campaign aimed at 12 to 18 year old boys and girls with the aim of preventing them from becoming perpetrators and victims of abusive relationships by encouraging young people to re-think their views of violence, abuse, controlling behaviour and what consent means within their relationships.

Safe Lives also recently published their latest policy report "Getting it right first time".

This focuses on the need to create a system to find every family as quickly as possible, and get the response right, first time, for every family.

Safe Lives suggests that all mainstream services must create an environment where any member of the family can tell someone about domestic abuse, and know that it will be acted on. And every professional should make identifying domestic abuse part of what they do, day-to-day – they should ask about domestic violence whenever they are worried about a family

Editors Note: It's encouraging to see from these national policy updates that with both Somerset's interpersonal violence strategy and its integrated model for its domestic abuse service (SIDAS), that we are definitely on the right lines in achieving a modern fit-for-purpose way to support victims and survivors of domestic abuse!

Modern Slavery Latest News

Somerset Interpersonal Violence Strategy

Did you know that Somerset has a strategy covering domestic abuse and sexual violence? This is overseen by the Safer Somerset Partnership – a group of statutory organisations who work in partnership to tackle crime, disorder anti-social behaviour and to reduce re-offending.

This has four key themes:

- 1) Prevention Training, Awareness and Early Engagement
- 2) Provision of Quality Services for Domestic Abuse and Sexual Violence Victims
- 3) Partnership Working
- 4) Risk Reduction and Justice Outcomes

There are lots of actions that you can get involved with – for example, theme 1 (Prevention) has these aims:

- Aim 1) Organisations (private and public sector, charity and statutory, small and large) understand the impact that domestic abuse has on its workforce.
- Aim 2) Any professionals working with the public is able to identify the signs of domestic abuse and knows how to respond including referring into specialist services as appropriate
- Aim 3) Reduce number of younger people (aged 18 years and under) who think abusive behaviour or any intimate partner abuse is the "norm", together with an increase in awareness that specialist support services are available
- Aim 4) Somerset communities can challenge myths surrounding domestic abuse, and sexual violence and to challenge perpetrator behaviour

New Report – Improving Access to Domestic Abuse Services Across Avon & Somerset for LGBT victims

In 2014, the Avon and Somerset Police and Crime Commissioner issued funding to Safer Bristol, to improve access to domestic abuse services in the region for Lesbian, Gay, Bisexual and Trans (LGBT+) communities. This project was carried out by Next Link and the Diversity Trust, and included consultation and research with victims, survivors and professionals.

The report has made a number of recommendations, including that professionals in both specialist and generic services receive training to help improve the identification and response to victims of domestic abuse.

A new LGBT and DA course is being added to the regular county domestic abuse training plan, and the date for the first course will be confirmed soon. In the meantime you can find the report online at http://www.somersetsurvivors.org.uk/information-for-professionals/.
