## **Supply Issues Update for Primary and Secondary Care: December 2019**

## **New Issues**

## Injectables

#### Amikacin 100mg/2ml injection

- Vianex SA are out of stock until end January 2020 due to manufacturing delays.
- Amikacin 500mg/2ml injection remains available.
- Review local protocols, ensuring that all those affected are aware of this issue and that consideration is given to mitigating the risks associated with switching to a different strength of amikacin injection.
- A Medicine Supply Notification was issued to secondary care on 19 December (attached).

#### Benzylpenicillin 600mg and 1.2g injection

 Thornton and Ross were out of stock of benzylpenicillin 600mg and 1.2g powder for solution for injection but supplies of both 600mg and 1.2g injection became available during w/c 16 December 2019

### Human C1-esterase inhibitor (Berinert) 500IU powder for reconstitution and injection

- CSL Behring, the sole manufacturer of the Berinert brand, will have limited supplies until 30 December 2019.
- There is sufficient stock available to maintain supply to all existing patients on continuous home treatment.
- Specialist centres are no longer required to actively switch patients who are on continuous home therapy to alternative treatments.



- Patients who have already agreed to switch should continue to be supported to do so.
- There is insufficient stock available to replenish stock for inpatient and A&E use.

## Midazolam 50mg/10ml solution for injection ampoules

- Hameln and Accord are out of stock until 31 January 2020.
- Midazolam 10mg in 2ml ampoules remain available from Hameln and Accord.
- Review local protocols, ensure that all those affected are aware of this issue and that consideration
  is given to mitigating the risks associated with switching to a different volume of midazolam
  (5mg/ml) ampoule presentation.
- A Medicine Supply Notification was issued to secondary care on 2 December (attached).

## <u>Orals</u>

#### Cefuroxime (Zinnat) 125mg/5ml oral suspension

- GSK, sole supplier is out of stock until w/c 16 December 2019.
- Alternative cephalosporin suspensions remain available.

#### Clonidine 25microgram tablets

- Accord are out of stock and unable to advise a resupply date.
- Limited supplies are available until January 2020.
- A clinical memo from UK Medicines Information (UKMi) will be published on the SPS website.
- A Medicine Supply Notification will be issued to primary and secondary care shortly.

## Co-careldopa 25mg/100mg tablets

- Teva, a generic supplier is out of stock and is currently unable to provide a resupply date.
- MSD, the supplier of the brand *Sinemet Plus* can cover supply for the whole market during this time.

#### Diclofenac 75mg and misoprostol 200mcg (Arthrotec 75) modified release tablets

- Pfizer, sole supplier is out of stock until late December 2019.
- Arthrotec 50 tablets remain available.
- There are several alternative suppliers of diclofenac 75mg modified release tablets.

#### Haloperidol (Serenace) 500 microgram capsules

- Teva, sole supplier of the capsule formulation is out of stock and currently unable to provide a resupply date.
- Haloperidol 500 microgram tablets are currently available.
- A Medicine Supply Notification was issued to primary and secondary care on 18 December (attached).

## Lansoprazole (Zoton FasTabs) 15mg and 30mg dispersible tablets

- Pfizer will be out of stock of the brand Zoton FasTabs from 30 December until 24 January 2020.
- Generic lansoprazole 15mg and 30mg orodispersible tablets remain available.
- For patients prescribed Zoton FasTabs by brand who do not have sufficient supplies for the out of stock period, clinicians should consider prescribing the generic product.



#### Moclobemide 150mg and 300mg tablets

- Mylan is currently out of stock of moclobemide 150mg and 300mg tablets.
- Mylan are expecting moclobemide 150mg and 300mg tablets back in stock March 2020 and April 2020, respectively.
- Sandoz is in stock of moclobemide 150mg tablets, however, is out of stock of moclobemide 300mg until January 2020.
- Unlicensed moclobemide 300mg tablets are available from importers; lead times vary.

## Others

#### Colestipol (Colestid) 5g granules

- Pfizer, sole supplier is out of stock of Colestid Orange sachets until 20 December 2019.
- Colestid plain sachets are currently available but will be out of stock from 23 December until 21 February 2020.

#### Fluorouracil (Efudix) 5% cream

- Mylan, sole supplier of Efudix 5% cream is out of stock until 23 December 2019.
- Unlicensed fluorouracil 5% is available to order from importers; lead times vary.

#### Tostran (testosterone) 2% gel

- Kyowa Kirin, sole supplier has been experiencing intermittent supply issues with this product over the last few months.
- Limited supplies are available but should resume to normal levels by end of December 2019.

## Ongoing Issues Injectables

#### Adrenaline Auto-Injectors (AAIs)

 Recent supply issues affecting some brands of AAIs has impacted on all manufacturers, however, there are currently sufficient supplies overall to meet normal UK demand.

#### Emerade (Bausch & Lomb UK Ltd)

- On 28 November, the MHRA issued a Class 2 pharmacy level recall for all strengths of Emerade devices following reports from the manufacturer, Bausch & Lomb UK Limited, of Emerade devices that have failed to activate. See link:

- On 29 November, DHSC issued a Supply Disruption Alert (SDA) with advice on how to manage patients affected. See link:

- The MHRA can confirm, following discussion with DHSC that Emerade stock held by pharmacies that has been designated for the flu vaccination/emergency use, should not be subject to the recall.
- This stock should have been in accordance with the recommended storage conditions and therefore should not be impacted by the temperature issues that have been highlighted in the alert.



 When renewing the adrenaline in your anaphylaxis kits (once Emerade/AAI devices have expired/been used), all staff are alerted to please stock ampoules (see adrenaline 1:1000 ampoules below).

#### *Jext (ALK-Abello Ltd)*

- Jext 150 microgram devices are currently available.
- Unlicensed Jext 300 microgram devices are being supplied through Alliance Healthcare via the PIP code: 801-6941 (see company letter attached).
- Specific batches of UK licensed Jext 150 micrograms and 300 micrograms have received MHRA approval for extended use by four months beyond the labelled expiry date.
- Clinicians should check with patients requesting new Jext 150 micrograms and 300 micrograms to
  establish if they currently hold one of the batches that can be used beyond the listed expiry. If one of
  the listed batches is held, further supplies should be delayed until the extended expiry date,
  counselling the patient on the extended expiry.

#### EpiPen/EpiPen Junior (Mylan)

- Supplies of both EpiPen and EpiPen Junior are currently available via a prescription validation process.
- Community Pharmacies can place orders for up to a maximum of two EpiPen's per prescription. Trusts place orders via Mylan's customer service team.
- Hospitals should request EpiPen's from the Mylan customer services team
   (mguk customer.services@mylan.co.uk; +44 (0) 1707 853 100) with information including the
   number of the pens required, the reason for need and their Alliance Healthcare account number.
- Specific batches of EpiPen 300 micrograms have received MHRA approval for extended use by four months beyond the labelled expiry date.
- Clinicians should check with patients requesting new EpiPen 300 micrograms to establish if they
  currently hold one of the batches that can be used beyond the listed expiry. If one of the listed
  batches is held, further supplies should be delayed until the extended expiry date, counselling the
  patient on the extended expiry.

#### Adrenaline 1:1000 ampoules for anaphylaxis kits

- Adrenaline 1:1000 ampoules are currently available in sufficient quantities to meet normal demand.
- Some healthcare professionals may be holding an AAI in preference to adrenaline ampoules, to treat anaphylactic reactions; this should not be necessary.
- All healthcare professionals providing services where anaphylaxis treatment may be required, including but not exclusive to flu vaccination services, should have the competency to draw up and administer intramuscular adrenaline from ampoules with a normal syringe and needle.
- During the current shortage, please use ampoules and not auto-injectors to replenish anaphylaxis kits. Remember to include the relevant dosing charts, syringes and needles.
- The Green Book and Resuscitation Council guidance provides additional advice to healthcare
  professionals on the use of adrenaline in response to anaphylaxis. Pharmacists providing vaccination
  services may also wish to refer to PSNC FAQs. There is an expectation that healthcare professionals
  should use adrenaline ampoules in preference to Emerade or other AAIs.



## Botulinum toxin type A (Azzalure) 125unit injection

- Galderma Ltd will have intermittent supplies until February 2020 due to supply challenges and increased demand.
- If Azzalure (which is only indicated for cosmetic use) is not available, *Botox* 50, 100 and 200unit and *Bocouture* 50 and 100unit can be used and are currently in stock but are not exact equivalents.
- Clinicians should refer to the SPCs for dosing.
- Galderma Ltd have supplied the following email for availability enquiries:

#### Crisantaspase (Erwinase) injection

- Porton Biopharma, the manufacturer of Erwinase, have had ongoing manufacturing issues affecting this product for the past 1-2 years with intermittent supply issues expected until mid-2020.
- Jazz Pharmaceuticals distributes Erwinase and supplies are currently available.
- Jazz Pharmaceuticals works closely with the clinical networks and supplies are prioritised on a patient need basis in conjunction with the treating clinicians.

#### Diamorphine 5mg and 10mg injection

- Accord are out of stock until March 2020 due to ongoing issues at their manufacturing plant in Europe.
- Wockhardt have insufficient stock to cover full forecasted demand in both primary and secondary care
- There are insufficient volumes of other strength diamorphine injections to cover any shortfall.
- Primary care, private hospitals, hospices and substance misuse treatment centres can continue to order diamorphine, unrestricted, from usual wholesalers.
- Secondary care should:
  - reduce orders of diamorphine 5mg injection to 25% of historical demand;
  - order diamorphine 10mg injection up to 60% of historical demand;
  - discuss this supply issue with clinical colleagues and consider local prioritisation of available diamorphine 5mg and 10mg stock;
  - continue to order morphine 10mg injection from Martindale in line with historic demand. Martindale CANNOT support increased orders;
  - order additional morphine 10mg injection from Hameln, who can support this supply issue;
  - consider how you will manage having two morphine 10mg injection presentations in your departments;
  - let your regional procurement specialist know of any local issues or if you are considering using an alternative other than morphine and;
  - cascade onto any relevant networks, who may find this information useful.
- For any concerns around patient safety, please contact your local Medication Safety Officer who will escalate to Nicola Wake (Medication Safety Lead, Specialist Pharmacy Service).

#### Digoxin (Lanoxin) 250mcg/ml injection

- Aspen, sole supplier are out of stock until February 2020.
- Unlicensed imports are available; lead times may vary.

## Medroxyprogesterone acetate (Sayana Press) 104mg injection

- Pfizer are out of stock of Sayana Press injection until further notice due to manufacturing delays.
- Depo-Provera (medroxyprogesterone acetate 150mg) is currently available and able to support the market during this time, should clinicians deem a switch appropriate.

#### Mitomycin 2mg/10mg/20mg injection and mitomycin 40mg intravesical solution (Mitomycin-C)

- Kyowa Kirin are out of stock due to quality control release and manufacturing delays with no date for resupply.
- No alternative supplies of UK licensed mitomycin are currently available in sufficient quantities to support this gap in supply.

- Extra supplies of Medac mitomycin 40mg intravesical kits have now been exhausted with more stock expected to be available in the coming months.
- Trusts who usually order Medac mitomycin 40mg intravesical kits can continue to do so. All others
  are requested not to contact Medac directly until instructed to do so by their regional procurement
  lead.

#### Oily Phenol 5% (almond oil) injection

- Martindale, sole suppliers are out of stock due to packaging delays until January 2020.
- There is no stock remaining in wholesalers.

#### Procyclidine 10mg/2ml injection

- Accord, sole supplier, are out of stock until March 2020.
- Consider sharing remaining stock locally with the support of your regional procurement lead.
- Unlicensed imports of procyclidine are not available.
- An alternative injectable anticholinergic agent, benztropine mesilate (unlicensed), is available from pharmaceutical importers.
- A medicine supply notification has been shared with secondary care (attached) which provides further information.

#### Sodium thiosulfate 12.5g/50ml solution for injection vials

- Hope Pharmaceuticals, sole supplier, are currently experiencing a long term out of stock.
- UK licensed *Nithiodote*, also by Hope Pharmaceuticals, contains 1 vial of sodium thiosulfate 12.5g/50ml and 1 vial of sodium nitrite 300mg/10ml and is available to order at no extra cost.

#### Somatropin (Genotropin) 5.3mg GoQuick

- Pfizer are out of stock until mid-January 2020.
- All other doses and presentations within the Genotropin range remain available.
- A copy of the DHCP letter can be found attached.



#### Tetracosactide 1mg depot injection

- Mallinckrodt, sole suppliers will be out of stock until the second half of 2020.
- Unlicensed imports are available; lead times vary.

#### Tobramycin 240mg/6ml injection

- Pfizer are out of stock until early January 2020.
- There is sufficient 80mg/2ml available from both Pfizer and Flynn (via Alloga) to cover full usage and Trusts are advised to switch to this strength during the out of stock period.
- Reserve any 240mg/6ml injection for patients who are unable to switch to the 80mg/2ml, for example, those who use via a nebuliser.

#### Urokinase (Syner-KINASE) injection

- Syner-Med are currently in stock of all strengths of Syner-KINASE injection.
- Supply restrictions will likely remain in place until mid-2020.

## Orals

#### Carbamazepine (Carbagen) various preparations

- Carbamazepine is considered a Category 1 anti-epileptic medication and patients should normally be maintained on the same brand, however Mylan (manufacturers of Carbagen) will be out of stock of the below products until Q1 2020:
  - o Carbagen 200mg and 400mg immediate release tablets
  - Carbagen 200mg and 400mg modified release tablets
- Patients currently prescribed Carbagen tablets will need to be switched to an alternative brand of carbamazepine tablets during this time.
- Novartis, the manufacturer of Tegretol tablets, the alternative brand of carbamazepine, have confirmed that all presentations are currently available that they are able to support additional demand during this time for all affected strengths and formulations.

#### Co-fluampicil 250mg/250mg capsules

- Crescent are out of stock until the end of December 2019.
- Clinicians are advised to prescribe flucloxacillin and ampicillin capsules as separate preparations, considering patients' ability to swallow an increased number of capsules.
- Ampicillin 250mg and 500mg capsules are available from Crescent and Chemidex.
- Ampicillin oral suspensions (125mg/5ml and 250mg/5ml) are also available from Chemidex.

#### Colestyramine (Questran) Powder for Oral Suspension

- Cheplapharm are out of stock of Questran Powder 4g sachets until 2021.
- Unlicensed imports are available from importers; lead times vary.
- Limited supplies of Questran Light are currently available through Alliance Healthcare.



• Mylan have recently launched a generic colestyramine 4g light sachet that will be available in wholesalers 18 December 2019.

#### Diazepam 2mg/5ml oral solution

- Sandoz, sole supplier is out of stock until the end of February 2020.
- Diazepam 2mg/5ml (sugar-free) oral solution is available from alternative suppliers.

#### Disopyramide 150mg capsules

- Mylan, sole supplier is out of stock until January 2020.
- Unlicensed imports are available from importers; lead times vary.
- Disopyramide 100mg capsules (*Rythmodan*) are available from Sanofi.

  - The licensed initial dose of eletriptan is 40 mg.
  - The 20mg strength of eletriptan may be used as the starting dose in patients with mild or moderate renal impairment.
  - Although 40mg eletriptan tablets are available, there are no data on halving or crushing them to deliver a 20mg dose.
  - However, there are several other 5HT1-receptor agonists (triptans) available that patients can switch to. Please refer to BNF or local formulary.
  - Choice of triptan will also depend on which ones have already been tried. In patients with renal impairment, please refer to SPC to check if a dose reduction is required.

#### Ethinylestradiol 10microgram/50microgram tablets

- UCB, sole supplier is out of stock due to manufacturing issues and currently unable to advise a resupply date.
- Unlicensed imports are available; lead times vary.

#### Ethinylestradiol and norethisterone (Synphase) tablets

- Pfizer are out of stock until early January 2020.
- Alternative brands of phasic oral contraceptive tablets with a different dosing schedule and containing a different progestogen remain available.
- Unlicensed imports are available; lead times vary.
- A medicine supply notification has been shared with the NHS (attached) which provides further information.

- UKMi guidance for switching preparations below:
  - It is recommended that the same total daily dose of galantamine is administered to patients.
     Patients switching to the once-daily regimen should take their last dose of galantamine tablets or oral solution in the evening and start prolonged- release capsules once daily the following morning.

#### Hormone Replacement Therapy products (HRT)

#### Elleste oral HRT Range

- Mylan, sole supplier, has been experiencing ongoing manufacturing issues at their contract manufacturing site since the beginning of 2019.
- Mylan have now advised whilst new manufacturing arrangements are being confirmed, the Elleste range will be unavailable from the middle of December 2019 until mid-2020.

#### Evorel transdermal patch range

- On 24 October 2019, Janssen-Cilag divested the Evorel range (Evorel, Evorel Conti and Evorel Sequi) to Theramex UK Ltd.
- Theramex have advised a resupply date of February 2020.
- All preparations are now out of stock others are expected to last until early 2020.

#### Metoprolol 50mg and 100mg tablets

- There are ongoing supply issues affecting metoprolol 50mg and 100mg tablets.
- The issue has been caused by some manufacturers discontinuing the products and others having supply difficulties.
- Aurobindo-Milpharm are currently the sole supplier of both presentations in the UK.
- Supplies of both presentations are currently available but may be limited; supply is likely to be intermittent for several months.

#### Mianserin 10mg/30mg tablets

- Mylan, sole supplier is out of stock of both strengths until Q2 2020.
- For patients who do not have sufficient supplies of mianserin tablets for the duration of the expected out of stock period, clinicians should consider prescribing an unlicensed preparation of mianserin tablets as soon as possible in order to avoid abrupt withdrawal.
- Unlicensed imports can be sourced from abroad; lead times may vary.
- In order for pharmacies to dispense an unlicensed drug, FP10 prescriptions must indicate that a special is required/prescribed by the GP. This could include the GP annotating the prescription with the following wording: "special order".
- For patients in whom unlicensed imports are not appropriate, DHSC have commissioned clinical advice which recommends:

#### Patients who have been prescribed mianserin for < 6 months

- 1. GP to start mirtazapine at a low dose depending on clinical judgement and the Summary of Product Characteristics (SPC)
- 2. Consider psychological therapies

#### Patients who have been prescribed mianserin for > 6 months

- 1. GP to start mirtazapine at a low dose depending on clinical judgement and the SPC
- 2. Seek specialist secondary care advice on management options

#### Nifedipine (Adalat) tablets

- There are ongoing supply issues with the Adalat Retard and LA range from Bayer. Alternative nifedipine presentations continue to remain available from generic suppliers.
- Supplies of nifedipine 5mg and 10mg immediate release soft gel capsules are now available from Relonchem.

#### Phenelzine sulfate (Nardil) 15mg tablets

- Kyowa Kirin, sole supplier is out of stock until at least March 2020 due to manufacturing delays.
- Unlicensed imports are available from the following specialist importer companies: Clinigen, Target, Alium, Mawdsleys, Durbin, WEP Clinical and Waymade. Lead times may vary.
- Unlicensed imports can be obtained through normal wholesaler routes. If unable to obtain through wholesalers, pharmacists are advised to contact the relevant specialist importers directly.

- Pfizer, sole supplier is out of stock until 10 January 2020.
- Hypovase 0.5mg tablets remain available.

## Quinapril (Accupro) 40mg tablets

- Pfizer, sole supplier is out of stock until 27 December 2019.
- Accupro 5mg, 10mg and 20mg tablets remain available.



#### Quinapril 10mg/hydrochlorothiazide 12.5mg (Accuretic) tablets

- Pfizer are currently out of stock until 24 January 2020.
- There are several alternative combination preparations of ACE-Inhibitors with diuretics and UKMi have advised that patients can be safely switched, with clinical supervision.
- Unlicensed quinapril 10mg/hydrochlorothiazide 12.5mg tablets are available from importers; lead times vary.

#### Ranitidine 50mg/2ml injection

- This is now resolved, and ranitidine injection supplies are now available to be ordered from wholesalers and are not expected to be out of stock.
- An updated Medicine Supply Notification (MSN/2019/019U) was issued to secondary care on 9
  December (attached) with further information.
- Guidance on the management of an expected shortage to ranitidine <u>injection</u> issued in the SDA update (SDA/2019/005-U) on 27 November has been superseded by MSN/2019/019U.
- There is no change to the supply situation for <u>oral</u> ranitidine and the guidance issued in <u>SDA/2019/005-</u> U should continue to be followed.

- MSD are out of stock HBVAXPRO 10mcg vaccine until further notice
- GSK are confident they can support the increased demand during this time.

#### Measles, Mumps and Rubella (MMR) vaccine

- Limited supplies of Priorix (GSK) and MMRVAXPRO (MSD) are available for the private market (locally procured stock) until January and March 2020 respectively due to global increase in demand.
- This supply issue does not impact the nationally procured MMR vaccine used for the Public Health England's (PHE) national programme.
- Most of the MMR vaccinations provided in the UK are nationally procured by PHE and delivered as part of a national immunisation programme.

## Pneumococcal Polysaccharide Vaccine 23-valent vaccine (PPV23) vials and Pneumovax 23 pre-filled syringes

- MSD, sole supplier of PPV23 vaccine, have limited supplies of both the PPV23 vials and Pneumovax pre-filled syringes until February 2020.
- Public Health England (PHE) have issued guidance on how available supplies should be managed at
  this time. This guidance advises the need for the prioritisation of patients considered to be in the

#### Rabies vaccine (Rabipur)

- Limited supply of GSK's Rabipur is currently available. Supply issues resulting from manufacturing constraints have now resolved, however, GSK do not expect the situation to fully normalise until late December 2019.
- Sanofi Pasteur have confirmed they are able to support the full market during this time with their unlicensed Rabies vaccine, Verorab

## Discontinuations

## Collagenase clostridium hitsolyticum (Xiapex) 0.9mg injection (Swedish Orphan Biovitrum Ltd)

- Sobi are discontinuing Xiapex injection at the end of 2019 (see letter attached).
- Unlicensed imports are available; lead times vary.
- Sobi have informed all customers of the plan to discontinue this product.

#### Diltiazem (Slozem) 120mg/180mg/240mg/300mg capsules (Merck Serono)

- Merck are discontinuing their Slozem range with immediate effect and expect stocks to be exhausted by the end of February 2020.
- UKMi have advised prescribers to switch patients to equivalent strength diltiazem preparations.



#### Fluoxetine (Prozac) 20mg capsules and 20mg/5ml oral suspension (Eli Lilly)

- Lilly are discontinuing Prozac 20mg capsules and 20mg/5ml oral suspension from the market in December 2019.
- Generic fluoxetine capsules and oral suspension remains available from a number of suppliers.

#### Fluphenazine decanoate (Modecate) injection (Sanofi)

- Manufacture of Modecate (fluphenazine decanoate) injection has ceased
- Existing stock of Modecate Injection (25 mg/ml) expired in August 2019.
- Existing stock of Modecate Concentrate Injection (100 mg/ml) will expire in August 2020 stock will not be released after 29<sup>th</sup> February 2020.
- Prescribers should complete arrangements to transfer patients on Modecate to therapeutic alternatives under medical supervision.
- Unlicensed imports are available; lead times vary.

#### Hepatitis A vaccine (Havrix Monodose Adult and Junior) vials (GSK)

- GSK are discontinuing Havrix Monodose Adult and Junior vials.
- Please note that Havrix Monodose Adult and Junior <u>pre-filled syringe</u> presentations remain available.

## Insulin Human (Insuman Basal, Comb15 and Comb25) (Sanofi)

- <u>Insuman Basal vials</u> are being discontinued and supplies are expected to be exhausted by May 2020. Insuman Basal cartridges and pre-filled Solostar pen presentations remain available.
- Insuman Comb15 cartridges are being discontinued and supplies are expected to be exhausted by June 2020. There are no direct mixed 15%/85% insulin alternatives, but clinical advice indicates that this should not be particularly impactful from a clinical perspective.
- <u>Insuman Comb25 vials</u> are being discontinued and supplies are expected to be exhausted by June 2020. Insuman Basal cartridges and pre-filled Solostar pen presentations remain available.
- A copy of the DHCP letter can be found attached.

#### Ivabradine 5mg & 7.5mg tablets (Teva)

- Teva are discontinuing ivabradine 5mg and 7.5mg tablets from the UK market
- Other generic manufacturers have been made aware and have good supplies available.

#### Rolapitant (Varuby) 90mg tablets (Tesaro)

- Tesaro are discontinuing Tesaro tablets for the UK market with immediate effect and expect stocks to be exhausted by mid-December 2019
- There are three other licensed neurokinin 1-receptor antagonists available aprepitant, fosaprepitant, and netupitant (combo product with palonosetron, brand name Akynzeo).

#### Stavudine (Zerit) 20mg, 30mg & 40mg hard capsules (BMS)

- BMS are discontinuing Zerit (stavudine) hard capsules and supplies are expected to be exhausted by the 31 Dec 2019.
- This is an early date than BMS have previously communicated to healthcare professionals.

#### Theophylline (Slo-Phyllin) 60mg/125mg/250mg capsules (Merck)

- Merck have discontinued Slo-Phyllin capsules with immediate effect.
